

# EXECUTIVE ORDER NO. 311

## *Amending Executive Order No. 227 to Change the Composition of the National Civil Aviation Security Committee*

**WHEREAS**, the Republic of Palau adopted the National Civil Aviation Security Program (the “NCASP”) pursuant to Executive Order No. 227; and

**WHEREAS**, the NCASP sets forth the policies, procedures and practices to be followed to ensure the security of aviation in Palau; and

**WHEREAS**, Executive Order 227 created a National Civil Aviation Security Committee (the “NCASC”) and assigned to it certain duties, one of which is to review and, as necessary, to amend the NCASP; and

**WHEREAS**, the NCASC has determined that in light of the NCASC’s current composition the existing NCASP does not comply with the Standards and Recommended Practices (“SARPS”) of the International Civil Aviation Organization (“ICAO”), to which the Republic of Palau is a signatory;

**NOW, THEREFORE**, at the recommendation of the NCASC and by virtue of the authority vested in the President by Article VIII of the Palau Constitution and the applicable laws of the Republic of Palau, the President orders as follows:

Section 1. Amendment of Executive order No. 227. Section III. 1 of Executive Order No. 227 is hereby amended to read as follows, all other provisions of Executive Order No. 227 to remain the same:

**“1. Composition.** The NCASC shall be composed of the following representatives of the respective agencies and organizations:

- Administrator, Palau National Aviation Administration and/or Deputy Administrator
- Director, Bureau of Public Safety and/or Deputy Director Bureau of Public Safety
- Director, Bureau of Foreign Affairs or Designee
- Director, Bureau of Immigration or Designee
- Director, Bureau of Agriculture or Designee
- Director, Bureau of Aviation or designee

- Director, Bureau of Customs or Designee
- Postmaster, Palau Postal Service or Designee
- Attorney General or Designee

Ad Hoc ( non-voting ) members

- Manager, United Airlines
- Manager, Delta Airlines
- Manager Japan Airlines(JAL)
- Manager, Korean Air
- Manager, Asiana Airlines
- Manager, China Airline
- Manager, Palau Airways

**Note:** *A Designee of a Director must, at a minimum, carry the rank of Chief, and must be nominated by the Bureau Director to consistently attend the meetings of the NCASC. The respective airline managers shall have no vote in the decisions of the NCASC and may attend its meetings at the discretion of the voting members.*

A majority of the members of the NCASC must be present for a quorum to do business. All members of the NCASC shall serve at the pleasure of the President, who may replace or remove a member at his discretion.”

Section 2. Effective Date. This Executive Order shall take effect immediately on the date set forth below and shall remain in force and effect until amended or repealed.
