

## **Presidential Proclamation No. 13-92**

### ***To Honor the late Governor Crispin H. Emilio and Ordering that all Flags be flown at Half-Mast in his Honor***

**WHEREAS**, the late Governor Crispin H. Emilio was born on January 7, 1954, on Hatohobei to Tasiana Emilio and Emilio Moses; and

**WHEREAS**, the late Governor Emilio grew up on Hatohobei where he attended Tobi Elementary School until later attending Mindszenty High School in Koror where he received his high school diploma; and

**WHEREAS**, the late Governor Emilio served with distinction as the Magistrate Representative of the Hatohobei Municipality from 1981 to 1984; and

**WHEREAS**, the late Governor Emilio was elected as the Lt. Governor of the First Hatohobei State Government from 1984 to 1992; and

**WHEREAS**, the late Governor Emilio was then elected Governor of Hatohobei State from 1992 to 2000; and

**WHEREAS**, the late Governor Emilio was re-elected as the Lt. Governor from 2000 to 2004; and

**WHEREAS**, the late Governor Emilio was re-elected as the Governor of Hatohobei State Government from 2004 to 2008; and

**WHEREAS**, the late Governor Emilio was one of the founders of the Helen Reef Project in 2000 and was later appointed by the Traditional Chiefs to be their representative to serve on the Helen Reef Resources Management Program Board (HRRMP) until his recent passing; and

**WHEREAS**, the late Governor Emilio served as Land Registration Officer representing Hatohobei State from October 2010 to July 2013; and

**WHEREAS**, the late Governor Emilio is survived by his wife Francisca Emilio; his Aunt Maria Tarkong; Fermina Ngirusong; his brother Dominic Emilio; and his children Tekla Emilio, Dexter Emilio, Kelsey Emilio and Kelly Emilio; and

**WHEREAS**, the passing of late Governor Crispin H. Emilio is a great loss to his family, his relatives, his friends, his clan, the community of Hatohobei State, and the people of the Republic of Palau; and

**NOW THEREFORE**, pursuant to 1 PNC §§ 501 et. seq. and Executive Order No. 24, as amended by Executive Order No. 292, I, Tommy E. Remengesau, Jr., President of the Republic of Palau, hereby proclaim that as a display of the respect his country and his fellow citizens have for the late Governor Crispin H. Emilio, all flags regularly flown within the jurisdiction of Palau, and all flags of the Republic of Palau flown at the Embassies and Consulates of Palau in other countries, shall be hoisted at half-mast for a period of three (3) days, commencing July 11, 2013.
